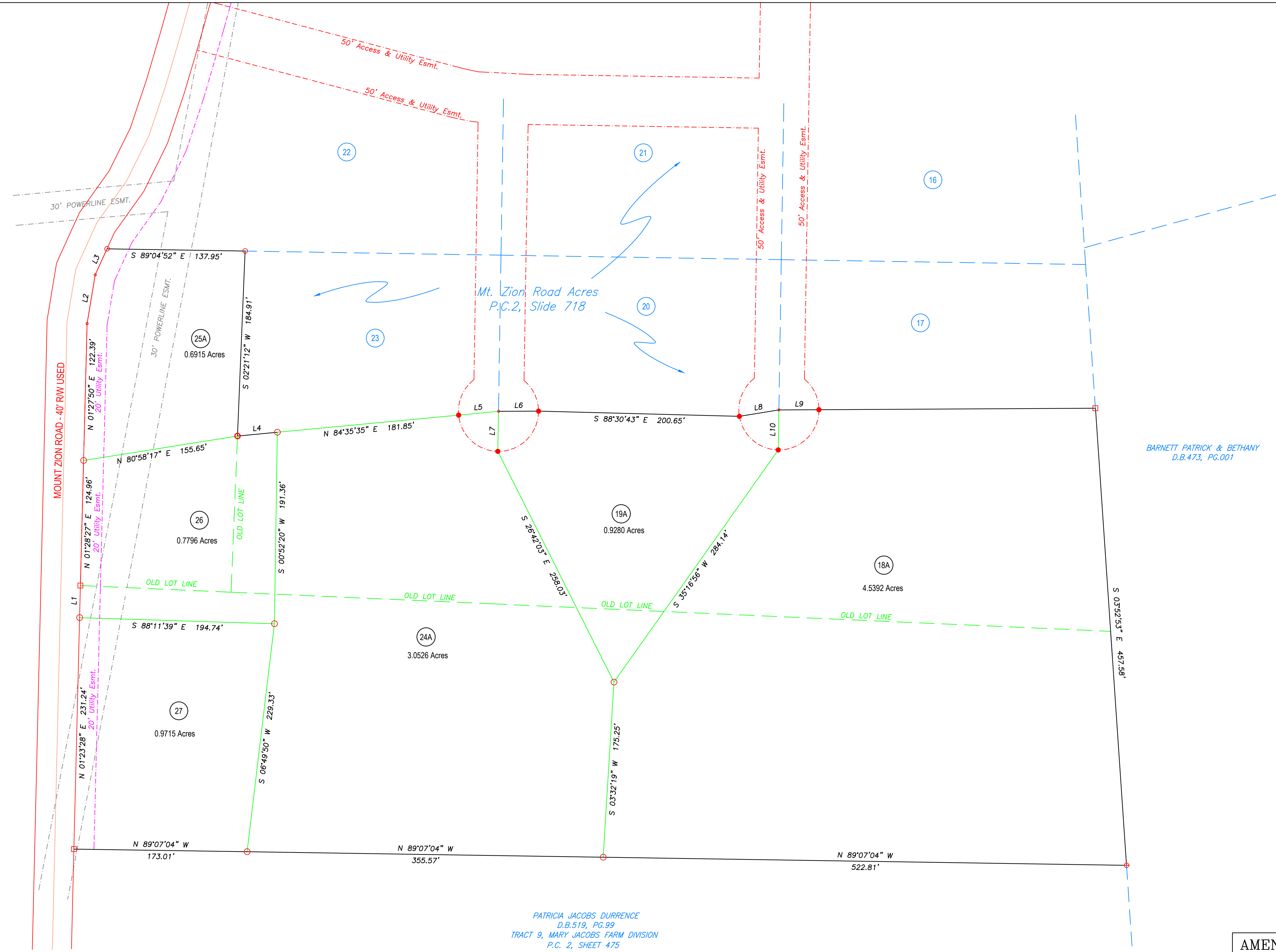
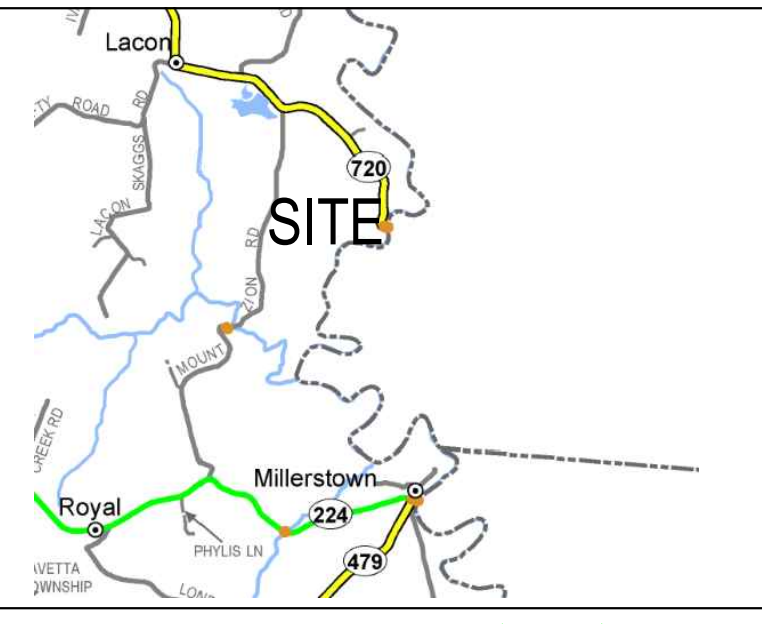


BEARINGS-KY STATE PLANE SINGLE ZONE

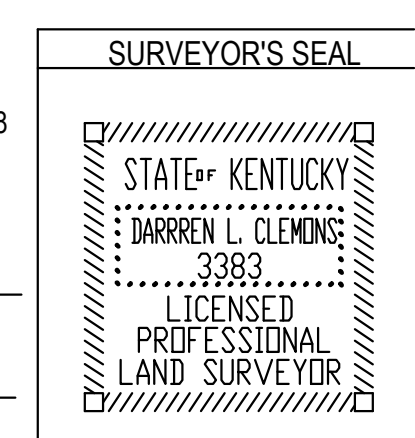
